## From the desk of our Executive Director

When we achieve a milestone, it gives us an opportunity to pause and rewind. Once the euphoria dies down, it triggers some soul searching. When TIDE turned 25 in May 2018, it made internal stakeholders reflect on the journey till now and, more importantly, where we are headed.

At 25, we would like to focus on how society benefits from our work and what can we do better. For this, we realize that we must show 'Impact at Scale'. Impact at scale is not necessarily scaling activities but strategizing programs to maximize the impact in the most efficient manner. For instance, with our popular Sarala stove construction training and dissemination model, our impact is already scaling at 10x through partnerships; the next goal is to make it 100x or 1000x utilizing digital tools and leveraging more partnerships.

Another focus under the 'Impact at Scale' exercise is capacity building of the organization and team. This includes technical expertise and soft skills. The workforce at TIDE is getting younger and we would like to enable work life balance along with job satisfaction, career growth opportunities and attractive remuneration. We are investing on systems and processes for monitoring and impact assessment. We have a communications strategy in place and are leveraging social media.

We have revisited our thematic focus areas and brought them under three umbrella areas of Biomass Technologies, Energy & Environment Conservation, Gender & Livelihoods.

TIDE strongly believes in leadership transitions to ensure organization sustainability. Effective April 2019, Svati Bhogle, our CEO, stepped down as the head of the organization after close to two decades of holding the post. Svati has been the face of TIDE for a long time and has steered the organization in the most illustrious way. Her technical expertise and charisma are unparalleled. She will continue to be associated as Chairman of the Board and Organization Mentor. Our Council of Management (Board) now has Svati Bhogle as Chairman and Mr. Jayachandra as Secretary. The Council has nominated the Executive Director to be the Chief Executive of the organization. We thank Mr N V Krishna for his stewardship as the Chairman of TIDE in the last decade.










# Biomass Technologies

#### Highlights

Biomass is the source of all heat energy for cooking, bathing, space heating and livelihoods in rural India. Given the variety in need, type of biomass, capacity of operations and temperature required, there is both an enormous opportunity and need in designing customized biomass energy products to suit a range of applications.

TIDE's work focuses on biomass combustion. It has in-house capacity to carry out user need identification, design and customize products that burn efficiently and cleanly, demonstrate the same in user locations and support other organizations in the dissemination of technologies. It is working with partners who have a strong grass root presence to disseminate technology in their regions of influence.

TIDE has designed a range of biomass fired stoves and dryers over the years; in 2018-19, it worked on field adaptation of forced draft stoves (Agni Sakhi domestic stove and Agni Mithra stove for commercial cooking), on site constructed stoves for midday meals. and large stoves for food factories producing fried snacks.

TIDE Slate, a digital platform, has emerged as a new initiative in remote learning for stove construction. The biomass group looks forward to using this facility extensively for Sarala stove. The same platform can be used for creating lessons in construction of midday meal and other stoves.

In the coming year, we look forward to adding more partners for technology dissemination and extending our outreach to other parts of India, especially to Chattisgarh, Orissa and the North Eastern states.

#### **Case Story**

Sarojamma is a housewife who lives in Sadapalli Tanda village on the border between Karnataka and Andhra Pradesh. She used a traditional mud stove for all her cooking. Not only did her small kitchen, and the rest of her house, fill with smoke, the stove used a lot of firewood. Her husband, son and sometimes Sarojamma herself, spent 2 or 3 hours, at least twice weekly, to gather the firefood. In the monsoon season this was an even bigger challenge. Ms. Manjula, the field worker for Agricultural Development and Training Society, TIDE's local partner in Bagepalli, learnt of Sarojamma's troubles. She requested TIDE to provide Sarojamma with an Agni Sakhi stove.

Agni Sakhi is a smokeless stove developed by FEAST and disseminated by TIDE. It uses 60 to 70% less firewood than a traditional stove. As it is a mobile stove Sarojamma no longer needs to cook in her small kitchen. The solar charged fan ensures that she can comfortably cook wherever she chooses to cooks.

TIDE distributed 25 such stoves with solar power for fans to needy women like Sarojamma.

## Energy & Environment Conservation









#### Highlights

TIDE's work in this space now covers the broad spectrum of Energy, Climate Change and Environment.

In 2018-19, TIDE initiated co-curricular programs in schools targeting students, school management and corporate volunteers. The engagement includes delivering interactive modules focusing on natural resource conservation, interventions in the school on energy, water, waste management, local community involvement, civic awareness for children and other relevant issues. The highlight of the program is the high level of corporate volunteer engagement we have achieved. We expect to work with ± 10 schools across 2 cities in the coming year and evolve a model for larger reach. Assessing learning outcomes of this program across the stakeholders is a key part of the program.

Our flagship program Vidyut Rakshaka continued to benefit consumers reaching 5000 + consumers across 3 cities, and drawing attention of policymakers. Being selected as winner of the Bengaluru Urban Innovation Challenge, given by Tata Center of Development at University of Chicago and the Government of Karnataka, is a great validation of our work in this area.

With this award, we will be scaling our program in an entire sub division of Bangalore and showing how it can be integrated with Demand Side Management (DSM) initiatives of utilities & distribution companies. We will be working on growing the reach of the program through our mobile app VidyutRakshaka.

Through a pilot program with 10 apartments, we assessed energy consumption and opportunities for energy efficiency and renewable energy for common area usage. This study has led to the development of an open source tool. We expect to do more work in this area in the coming year.

#### Case Story



About 20-25% of maintenance costs in apartments is estimated to go towards electricity use for common amenities. A joint study by TIDE and World Resources Institute (WRI) India, focused on studying the electricity cost to find potential for savings. The study attempted to break down electricity consumption and costs, identify interventions for efficient use, and to shift from existing technologies to cleaner ones where possible.

The study assessed electricity use in the common services of apartments. Ten apartment complexes participated in the study, of which nine were over 10-years-old. From the initial interaction with the managers and RWAs, it was clear to the study team that having a baseline, i.e., information about the current state of affairs, was the first requirement. The team collected electricity bills from facility managers and RWAs, and compiled an inventory of electrical appliances, their rating and operations through a detailed questionnaire.

The team also did a walk-through of the common areas to validate this data, and to observe behavioural and operational patterns in the use of appliances. Common area lighting, water pumps, Diesel Generator (DG) sets and elevators were some common services covered in the study.

With this study, the apartments were able to see for the first time how the connected load and actual consumption were shared between different appliances. This helped prioritise areas for intervention. Many apartments paid high fixed charges due to low utilisation of their sanctioned load.

The study also brought out the correct per unit cost of electricity for each apartment.

The team conducted energy audits of 60 water pumps and DG sets that gave 24/7 power backup.

The study was concluded with a detailed report to each apartment, capturing the baseline and recommendations. The study found that each apartment could save 10 to 20% of their energy use, through a combination of no-cost, low-cost and investment-based interventions across different appliances.

## Gender & Livelihoods

#### Highlights

Taking cognizance of the fact that TIDE's work in livelihoods space is overarching across men and women, we have renamed our Women & Livelihoods focus area as Gender & Livelihoods.

In 2018-19, we adopted a market driven approach to help improve the profitability of the 30 enterprises we helped set up in the last 2 years. We have also observed the ecosystem of rural enterprises and identified certain gaps and opportunities, mainly to do with product quality standardization, certifications, packaging, etc. Based on these findings, TIDE is proposing to provide facilitating services for rural enterprises from our Women Technology Park (WTP).

Our baby of the year was the QUEEN program, a bottom up grass root initiative to nurture rural women as community leaders. The unique aspect of QUEEN is the methodology to work with women mentors, and promoting the idea of REAL QUEENS FIX EACH OTHERS' CROWN!

During the year, we took baby steps towards our vision of WTP 'Self reliant rural women contribution to nation's goals', through a two-pronged approach on 'Economic' and 'Social' empowerment. For the economic empowerment, we are equipping WTP to provide employment opportunities for the local population.

Our favourite Sarala stove builders' program is flourishing across the country, and is recognized by the Skill Council of Green Jobs and National Skill Development Council.

With our various initiatives focusing on rural population, we have undertaken village development program focusing not just on interventions but on building the capacity of the Gram Panchayat and the local leaders. We hope to take this forward in the coming year.

#### **Case Story**

Guddhatti is a remote tribal village of 70 families in Gubbi Taluka, Karnataka. This village has largely been ignored by the Kondli Gram Panchayat under which it belongs.

TIDE with the support of FANUC India did a comprehensive survey of the demand & supply of water in the village. Water tests carried out at three borewells and in households across the village showed hardness above permissible limits. Water drawn from some locations also showed E Coli contamination. The village has access to a Water ATM installed by the government about 2 kms outside the village. However, distance and social issues proved to be a deterrent with residents preferring not to use the facility.

A community-level water ATM, was installed with Aqua Safi as a Technical partner on June 26, 2018. A Village Water and Sanitation Committee was formed to monitor proper use and maintenance of the Water ATM.






