Title of the service required	Supply and Installation of a 500 kg (wet-waste) Hybrid Solar–Electric Dryer
Brief explanation of the product/service required	A hybrid solar–electric dryer is required for drying shredded wet organic waste at the Chintamani Biochar Pilot Unit. This dryer will use solar energy during sunny periods and automatically switch to electric heating during low-sun or monsoon conditions. Achieving consistent moisture reduction is essential to ensure smooth daily feeding of the biomass pyrolyser and stable biochar production.
Specification of the product/type of service	 Capacity: 500 to 600 kg per batch of shredded waste Type: Solar cabinet dryer with forced draft and electric backup Performance: Ability to reduce moisture from 85–90% to 10–20%; Drying cycle 24 hours to 36 hours under normal sunlight. Hybrid operation: Primary: Solar heating using UV-stabilized polycarbonate or glass panels Backup: Electric heating (coil / resistive heater / hotair blower) for monsoon & cloudy conditions Automatic or manual mode switching Construction: Corrosion-resistant frame; UV-stabilized transparent cover; Weather-resistant structure suitable for outdoor installation Tray/Racks: Suitable for 5–10 cm bed depth

All submitted quotations will be evaluated based on the following criteria

1. Technical Compliance (40%)

- a. Adherence to the required specifications
- b. Quality of materials and build
- c. Safety features
- d. Warranty period
- e. Availability of installation and training support

2. Financial Proposal (30%)

- a. Total cost (inclusive of taxes and delivery)
- b. Cost-effectiveness in comparison to other bids
- c. Transparency of pricing (no hidden charges)

3. Vendor experience and Capability (15%)

- a. Experience in supplying similar equipment
- b. Past performance with government/NGO/municipal clients
- c. Technical expertise and competent service team

4. After-Sales Service & Support (10%)

- a. Availability of service centre or on-site support
- b. Response time for maintenance
- c. AMC (Annual Maintenance Contract) options

5. Delivery Timeline (5%)

a. Ability to deliver and install within the required timeframe

Payment Terms

1. Advance Payment (50%)

- a. 50% of the total contract value will be released as advance
- b. Only upon submission of a Bank guarantee or a Security Cheque equivalent to the advance amount.

2. Delivery Payment (30%)

- a. 30% will be released after successful delivery of the shredder machine at the designated site.
